ABOUT US

The Catholic Foundation of Northwest Pennsylvania inspires and unites Catholics in supporting their faith community and creating a Catholic legacy. We assist donors by providing for the long-term needs of the Catholic ministries in their community.

WHAT IS A COMMUNITY FOUNDATION?

A community foundation is a tax-exempt, publicly supported philanthropic organization with a long-term goal of building endowments in a geographic area. The Catholic Foundation is like other community foundations in that it is a grant-making charity that brings together the financial resources of individuals, families and businesses to support nonprofit organizations in its community. What's unique about our Foundation is the community it serves — the Catholic community in northwest Pennsylvania.

WHAT MAKES THE CATHOLIC FOUNDATION OF NORTHWEST PENNSYLVANIA UNIQUE?

Originally founded through generous donations to the 2001-2003 diocesan capital campaign, the Foundation is a 501(c)(3) corporation led by a layperson governing board of directors representing the three geographic regions of the Diocese of Erie. We work to promote socially responsible investing and connect generous donors with impactful and faithful organizations. We understand the value of stewardship and the unique desire of Catholics to provide a legacy of faith for future generations.

WHY CREATE AN ENDOWMENT?

Monies placed in such a fund, referred to as the principal, remain untouched, with only the income earned through its investment used to address stated needs. This ensures the availability of the funding in the future. Once established, an endowment can also serve as a channel for future giving.

WHO DOES THE FOUNDATION SERVE?

The Catholic Foundation helps individual donors create meaningful impact through planned giving and charitable fund management. We also work closely with parishes, schools and charities to build a vibrant philanthropic plan to support their ministry. The long-term investment expertise and oversight of endowment holdings by the Foundation's board of directors is a resource to finance councils and committees throughout the Erie diocese.

WHO HAS ACCESS TO FOUNDATION FUNDS?

Endowment funds held by the Foundation are restricted for the intended purpose stated in a legal agreement by the individual or organization initiating the endowment. The Foundation's volunteer lay board of directors oversees the governance and proper use of distributions from Foundation endowments.

Funds created by the Catholic Foundation provide asset protection from potential liabilities. They ensure the specified growth and lasting legacy of our Catholic communities.



PLANNING FOR THE FUTURE

When a visionary parishioner approached Fr. Tom Tyler about his interest in seeding an endowment for Holy Cross Parish in Fairview, Fr. Tom was grateful. He knew the importance of planning for the financial future of the parish. While working closely with the donor, Fr. Tom involved parish leadership with planning to help determine what could be done now to set the parish up for success in years to come. "With fewer priests, I know we will need to involve lay ministers more in our parish ministries," Fr. Tom shared. "We don't know what form new ministries may take years from now, but it is certain we will need resources to realize them. With this endowment, those who come after us will have some funds to adjust staff and programming." It's a faith-filled plan that reaches out to the next generation.

Other Holy Cross parishioners are embracing this giving option with planned and outright gifts, expressing their desire to secure the future of the parish.





A LASTING TRIBUTE

Ruthanne Beighley's enthusiasm is palpable when she says "Monsignor (Edward) Zeitler was the holiest and kindest man I have ever known." Their relationship developed while he led her through RCIA at Notre Dame Parish, Hermitage, in the late 1980s. "Monsignor encouraged my fiancé, Joe George, to participate in RCIA as my sponsor and he encouraged us to pursue annulments of our prior marriages," Ruthanne recalls fondly. "We both learned so much." Together with Father John Hindman, also at Notre Dame, "Msgr. Z" concelebrated their nuptial Mass on November 25, 1988.


"I feel that the endowment in his name and honor with the Catholic Foundation provides a

lasting tribute to this gentle and humble man," she says. "Hopefully, the fund will grow with contributions from others whose lives he touched and whose faith he strengthened."

Ruthanne was thoughtful about the purpose of this endowment and wanted it to benefit the parishes Monsignor served during his active ministry. "Involved in music ministry myself, I hope the fund can assist the three named parishes in maintaining quality instruments, growing music libraries and resources, bringing in renowned musicians and composers, and possibly, preparing and staging productions as was done the last few years at Notre Dame."

With her legal and business acumen, Ruthanne quickly identified the right partner for her gift. "The Catholic Foundation of Northwest Pennsylvania provides the lasting tribute that I ardently wanted. It also allows donors to specify their funds' objectives. It gave me the ability to designate not one, but three parishes that Monsignor Z served and whose ministries he fostered and loved very much."

For over 40 years, David Murphy has been an integral part of the Diocese of Erie, where he's handled financial resources and other business affairs across the 13 counties. Shortly after his retirement, David established an endowment to show his confidence in the diocese and the Catholic Foundation. TO HONOR AND SERVE

Sister Benita Repasky, late in her religious life, felt she had a calling to minister to the poor in the Shenango Valley. More than 35 years later, the Prince of Peace Center that she founded has grown tremendously. It has become a vital community resource, working to break the cycle of poverty by offering job training, money management, parenting, life skills training, as well as food, shelter and clothing to support adults and youth.

Sister Benita's legacy was honored and strengthened in 2018 when the board of directors at Prince of Peace Center created an endowment in her name. "This fund plants the seeds of faith, hope and love that will bear fruit in the form of financial stability for the Prince of Peace Center for generations to come," explained Joseph Flecher, executive director.



FIELD OF INTEREST ENDOWMENTS

The Catholic Foundation was founded in 2007 through the vision and generosity of donors who participated in the 2001-2003 diocesan capital campaign. Their gifts established four field of interest endowments that help fund programming and ministries throughout the diocese. Each year, earnings from these endowments are used to help finance the specific purpose for which each was created.



MAKING CHRIST PERSONAL — CLERGY HEALTH AND WELFARE

"With nearly 40 retired priests in our diocese, endowment funding for their health care helps us provide the needed services," expresses Bishop Persico. The Clergy Health and Welfare Endowment provides care and assistance for ongoing health care needs that are not presently covered by insurance, assistance with the present and future health needs of our senior priests and community-living-setting retirement facilities.

A \$69,730 grant was awarded in 2018.

MAKING CHRIST ACTIVE — CATHOLIC CHARITIES

This endowment assists programs that provide emergency services, counseling services and support for families and the needs of the poor and elderly.

A total of \$66,700 in grants was awarded in 2018.

One story of impact — St. Elizabeth Center's mission as a food pantry is to assist those in need in the Oil City area. Each month, they provide 200-300 households with groceries, nonperishable items, fresh produce, meat, and health and hygiene items. Director Douglas Kennedy says, "It is our hope that this food assistance will free up finances to help with other family expenses such as rent and utilities. The funds that we receive through Catholic Charities grants are essential to the continued existence of the St Elizabeth Center. Because of the generosity of donors, we can provide a variety of nutritious food to families in need as well as other household necessities. We are humbled to be able to interact with our client families who have become our friends. With the help of the grant funds received, we can fulfill our calling to be Christ's hands and feet."

MAKING CHRIST KNOWN — THE EDUCATION ENDOWMENT

This endowment assists with religious education and faith formation, diocesan-wide Catholic school scholarship and tuition assistance programs, lay ministry training and worship formation, and technology for education.

A total of \$138,862 in grants was awarded in 2018.

One story of impact — Seeking to further cultivate the faith of the youth in their community, Angela Felicetty, Michelle Boarts, and Madeline Amon, parishioners at the Church of the Beloved Disciple in Grove City, were awarded a grant from the Catholic Foundation to help fund a retreat for their high school students. At Notre Dame Vision, youth can discover and strengthen their relationship with God, connect and learn with others, and develop practices to live out their faith. The retreat is held on Notre Dame University's campus and is led by students from University of Notre Dame, Holy Cross College, and St. Mary's College. "Notre Dame Vision brought me closer to God," Mara Barrick said. "The trip made me recognize my flaws and how I relate to others. I learned how to avoid making the same mistakes and improve my faith."

MAKING CHRIST VISIBLE — THE EVANGELIZATION ENDOWMENT

This endowment assists parishes in offering models of welcome to Catholics in various stages of their faith journey, expanding media outreach through technology, efforts of faith formation and vocational promotion and support for families and singles, youth and young adults.

A total of \$35,742 in grants was awarded in 2018.

One story of impact — After months of dreaming, planning and collaborating, the Diocese of Erie has unveiled the first major overhaul of its website in more than a decade. Now www.ErieRCD.org is a vibrant and up-to-date resource designed to be both user-friendly and inspiring.

One key new element is a news hub, www.nwpaCatholic.com, a platform used to provide local, national, international and Vatican news, as well as links to diocesan Facebook and Twitter sites.

The upgrade — partially funded by the Evangelization Endowment of the Catholic Foundation — also allowed the diocese to offer each of the 97 parishes in the 13 counties of northwest Pennsylvania, a new state-of-the-art website, free of charge.

NOTES TO FINANCIAL STATEMENTS

- The Catholic Foundation of Northwest Pennsylvania was incorporated in 2007. The Foundation's purpose is to provide a permanent and secure funding stream to stabilize, strengthen, and grow the Church's mission and ministries in northwest Pennsylvania.
- Distribution Policy: The policy is reviewed annually by the board of directors. While by policy it can range from 2%-7%, distribution has typically been 4%-5% of the average market value over 12 rolling quarters.
- Investment Policy: The primary investment objective of the Foundation is the long-term growth of principal and generation of income. The funds entrusted to the Catholic Foundation are invested consistent with the Socially Responsible Investment Guidelines outlined by the United States Conference of Catholic Bishops.



As an independent nonprofit organization in service to the Catholic community of northwest Pennsylvania, the Catholic Foundation is governed by a dedicated board of directors comprised of Catholic lay men and women from throughout the diocese.
